

**RESOLUTION NO. 2011-70**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
RATIFYING AND AUTHORIZING THE EXPENDITURE OF FUNDS TO  
MID COAST GAS FOR COMPRESSED NATURAL GAS COMPRESSOR RENTAL  
AND MAINTENANCE IN THE AMOUNT OF \$15,450 AND AMENDING  
RESOLUTION NO. 2009-104 BY AN AMOUNT OF \$46,000  
[FOR A TOTAL NOT-TO-EXCEED AMOUNT OF \$150,000]**

**WHEREAS**, the City's Transit Division operates Compressed Natural Gas (CNG) buses and needs to purchase CNG fuel; and

**WHEREAS**, the City has paid \$15,450 in expenses and has invoices for an additional \$29,000, for an amount not-to-exceed \$150,000 in expenses relating to purchasing of fuel from Mid Coast Gas under the contract term; and

**WHEREAS**, on May 27, 2009 the City Council adopted Resolution No. 2009-104 authorizing the City Manager, or her designee, to rent CNG Compressors and reimburse labor costs required to maintain the compressors from Mid Coast Gas not-to-exceed \$104,000; and


**WHEREAS**, the use of the compressors by the City has required additional maintenance and rental costs than the amounts stated in Resolution No. 2009-104 in an effort to fuel efficiently; and

**WHEREAS**, the ratification of these expenditures is a priority of the City Council and has been appropriated in the Transit Division's Fiscal Year 2010-11 Budget.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby ratifies and authorizes the City Manager, or her designee, to pay the total unpaid expenditures to date to Mid Coast Gas in an amount not-to-exceed \$15,450.

**NOW, THEREFORE, BE IT FURTHER RESOLVED** that the City Council hereby amends the amounts authorized under Resolution No. 2009-104 for CNG Compressor Rental and Maintenance by an amount of \$46,000 for a total not-to-exceed amount of \$150,000.


