, A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE ACCEPTING THE PUBLIC IMPROVEMENTS FOR THE ELK GROVE PROMENADE MAJOR ROADS PROJECT

- WHEREAS, Elk Grove Town Center, L.P., a Delaware Limited Partnership (Developer), entered into an agreement with the City of Elk Grove entitled "Agreement Regarding Regional Mall, Fees and Infrastructure" (Agreement), on November 14th, 2007; and
- WHEREAS, Section 15 of the Agreement required the Developer to design and construct public improvements in accordance with the City of Elk Grove's Improvement Standards (1999 version) and Construction Specifications (2001 version); and
- WHEREAS, the City and the Developer entered into a Reimbursement Agreement in August of 2010 in order to resolve issues concerning the acceptance and payment for public infrastructure constructed pursuant to the Agreement; and
 - WHEREAS, the Bankruptcy Court approved the Reimbursement Agreement; and
- WHEREAS, pursuant to the order of the Bankruptcy Court, the City may release the funds held to reimburse the Developer, and may deduct for any unpaid liens from that amount; and
- WHEREAS, the Elk Grove Promenade Major Roads project represents the required public improvements; and
- WHEREAS, the County has confirmed that the water and sewer improvements are complete; and
- **WHEREAS**, the City has determined that the public improvements have been satisfactorily completed in accordance with City-approved improvement plans.
- NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby accepts the public improvements for the Elk Grove Promenade Major Roads project subject to the conditions of the Agreement Regarding Regional Mall, Fees and Infrastructure, the Reimbursement Agreement, and the order of the Bankruptcy Court.
