

RESOLUTION NO. 2011-95

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
APPOINTING LAURA KOBLER AND JAY PAWLEK AS MEMBERS
OF THE AFFORDABLE HOUSING LOAN COMMITTEE**

WHEREAS, on November 14, 2007 the City Council approved Resolution No. 2007-261 authorizing the formation of the Affordable Housing Loan Committee (the "Committee") in order to protect the health, safety, and welfare of the community and ensure that adequate housing for very low and low income households is provided in the City of Elk Grove, as the City provides loans to developers of affordable housing projects to assist in construction financing; and


WHEREAS, the Committee is a standing committee which consists of three members; the first member of the Committee is the City's Finance Director or his or her designee, each member and designated alternates must be approved by a majority vote of the City Council; and

WHEREAS, on March 9, 2011 recruitment was authorized to solicit applications to fill two vacancies on the Committee, one vacancy for the voting member for the non-profit representative, and one vacancy for the alternate member for the Northern California Building Industry Association (BIA) representative.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby appoints and confirms Rachel Iskow and John Costa as members of the Affordable Housing Loan Committee representing a non-profit affordable housing advocacy group and the Northern California Building Industry Associated respectively; and

NOW, THEREFORE, BE IT FURTHER RESOLVED that the City Council of the City of Elk Grove hereby appoints Laura Kobler and Jay Pawlek as alternate members of the Affordable Housing Loan Committee representing a non-profit affordable housing advocacy group and the Northern California Building Industry Associated respectively.


