

RESOLUTION NO. 2011-113

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO EXECUTE A TRAILS MAINTENANCE
AGREEMENT WITH THE COSUMNES COMMUNITY SERVICES DISTRICT**

WHEREAS, the City of Elk Grove (City) and the Cosumnes Community Services District (CCSD) own certain real property that provides a system of public trails consistent with the City's Master Trails Plan; and

WHEREAS, the City has an interest to facilitate the use of the trail system as a transportation system for alternative modes of travel such as bicycles and pedestrians; and

WHEREAS, the CCSD has an interest to facilitate the use of the trail system as a recreational facility; and

WHEREAS, the City and CCSD have used their own source of funds to provide maintenance of the trail system that exists on their respective real property that it individually owns; and

WHEREAS, the City has expertise in Pavement Maintenance and the CCSD has expertise in Landscape Maintenance; and


WHEREAS, to improve efficiencies, save costs and support the City's desire for a superior transportation use of the trail system and the CCSD's desire for superior recreational use, the City and CCSD agree to accept responsibility for maintenance activities of the trail system as shown in Exhibit "A" incorporated herein by this reference (including the funding and prioritization of such activities) based on the terms and conditions set forth in the agreement; and

WHEREAS, Exhibit "A" may be updated periodically to identify completed trails included in this agreement; and

WHEREAS, the City and CCSD shall jointly review and approve landscaping for future trails to ensure compliance with landscaping standards.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute a trails maintenance agreement with the Cosumnes Community Services District (CCSD) performing landscape maintenance and the City performing pavement maintenance throughout the City trails system.

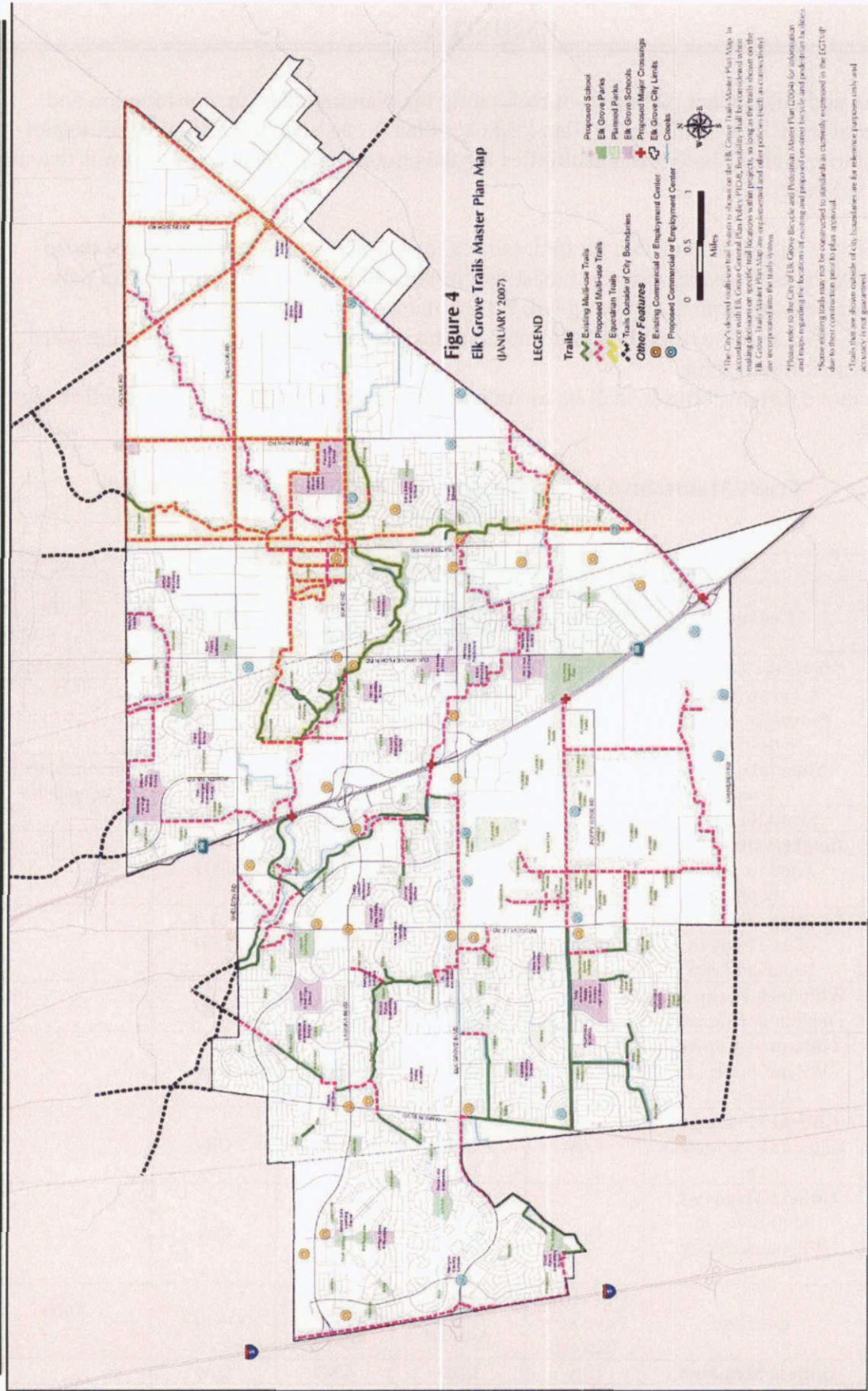


EXHIBIT A

Both the City and District are interested in facilitating the planning, design, construction and maintenance of the City's Trail Master Plan ("Master Plan"). As such the following principles shall be used to establish shared responsibilities for the ongoing maintenance of the trails that are defined in the Master Plan.

1. The City shall be responsible for maintaining the surface of all the trails except those trails with concrete surfacing that exist within Park Boundaries (ie, trails within park boundaries with asphalt surfacing will be maintained by the District).
2. The District shall be responsible for maintaining the landscaping and performing weed abatement for all trails.
3. The above responsibilities shall be assumed unless specified otherwise in the following table.
