

RESOLUTION NO. 2011-119

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AUTHORIZING THE CITY MANAGER TO EXECUTE A TWO-YEAR CONTRACT EXTENSION WITH FOOTHILL TRANSCRIPTION COMPANY, INC. FOR POLICE TRANSCRIPTION SERVICES IN AN AMOUNT NOT-TO-EXCEED \$120,000 [FOR A TOTAL COMPENSATION AMOUNT NOT-TO-EXCEED \$300,000 OVER FOUR YEARS]

WHEREAS, the Elk Grove Police Department utilizes transcription services to type daily police reports thereby decreasing desk time and increasing field time; and


WHEREAS, the City conducted a Request for Proposals to seek economies of scale for transcription services and found Foothill Transcription Company, Inc. to be the lowest responsive bidder; and

WHEREAS, Foothill Transcription Company, Inc. has provided good quality service to the Elk Grove Police Department; and

WHEREAS, the current contract with Foothill Transcription Company, Inc. expires on June 30, 2011 and provides for an optional two-year extension.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute a two-year contract extension with Foothill Transcription Company, Inc. for police transcription services in an amount not-to-exceed \$120,000 for a total compensation amount not-to-exceed \$300,000 over four years.


