**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
APPOINTING KIMBERLEY GARTH-JAMES TO THE SACRAMENTO REGIONAL  
HUMAN RIGHTS / FAIR HOUSING COMMISSION ADVISORY BOARD**

**WHEREAS**, the Human Rights / Fair Housing Commission was formed in 1963, the result of a joint powers agreement between the City and the County of Sacramento to promote harmony among the various groups in the Sacramento community; and

**WHEREAS**, with the adoption of Resolution Nos. 2007-35 and 2008-62 the City Council of the City of Elk Grove entered into a Joint Exercise of Powers Agreement with the Human Rights / Fair Housing Commission; and


**WHEREAS**, pursuant to Section 5 of the Joint Exercise of Powers Agreement, each member agency shall be represented by one Advisory Board member for every 50,000 in population living in the member agency's jurisdictional boundaries; and

**WHEREAS**, the California Department of Finance released on April 29, 2011 an official population estimate for the City of Elk Grove of 154,594 which exceeds the increment threshold of 150,000 residents to increase the number of Advisory Board members for the City of Elk Grove from two members to three members; and

**WHEREAS**, one vacancy currently exists on the three member Advisory Board.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby appoints Dr. Kimberley Garth-James to the Regional Human Rights / Fair Housing Commission Advisory Board.


