

RESOLUTION NO. 2011-150

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT WITH
SPINITAR, INC. FOR THE OPERATION AND MAINTENANCE OF CITY HALL
AUDIO VISUAL EQUIPMENT FOR A THREE YEAR TERM WITH THE OPTION OF
THREE, ONE-YEAR EXTENSIONS, IN AN AMOUNT NOT-TO-EXCEED \$397,300
OVER A SIX YEAR PERIOD**

WHEREAS, the existing contract for the Operation and Maintenance of City Hall Audio Visual Equipment is set to expire August 1, 2011; and

WHEREAS, the City has a need for operation and maintenance of the City Hall audio visual equipment in the routine course of business; and


WHEREAS, the City followed its purchasing ordinance requirements by issuing a Request for Proposals to solicit these services; and

WHEREAS, on July 6, 2011, proposals were received from two companies; and

WHEREAS, the proposal submitted by Spinitar, Inc. ranked highest and was determined to be the most responsive and advantageous to the City.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute a contract with Spinitar, Inc. for the Operation and Maintenance of City Hall Audio Visual Equipment for a three year term with the option of three, one-year extensions in an amount not-to-exceed \$397,300 over a six year period.
