

**RESOLUTION NO. 2011-157**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
REJECTING ALL BIDS FOR THE ELK GROVE CREEK TRAIL IMPROVEMENTS  
PROJECT (FALCON MEADOW TO MARKOFER SCHOOL) (PT0123)**

**WHEREAS**, an invitation to bid for the Elk Grove Creek Trail Improvements Project (Falcon Meadow to Markofer School) was duly advertised on June 17, 2011 and bids were opened on July 18, 2011; and

**WHEREAS**, on July 27, 2011 City of Elk Grove Public Works Department Staff recommended award of the construction contract to the responsible bidder submitting the lowest responsive bid; and

**WHEREAS**, it was determined by the City Council that additional public outreach was necessary before the contract could be awarded; and

**WHEREAS**, a public meeting notice was mailed to residences within 500 feet of the proposed project; and


**WHEREAS**, the public meeting was held on August 4, 2011 wherein a description of the proposed project was presented to approximately 24 residents; and

**WHEREAS**, a majority of the residents attending the meeting were not in favor of the project as presented; and

**WHEREAS**, there are currently no modifications that can be made to the existing project, as bid, that would alleviate the concerns of the residents.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby rejects all bids received for the Elk Grove Creek Trail Improvements Project (Falcon Meadow to Markofer School) (PT0123).


