WHEREAS, the East Stockton Boulevard Soundwall Renovation Project (Project No. WCE001) (Project) will structurally and aesthetically improve a non-functional facility; and

WHEREAS, the Project Description has been more precisely described in the staff report; and

WHEREAS, additional funds are needed in the current fiscal year to accelerate the Project timeline and complete preliminary engineering for the Project; and

WHEREAS, an amendment to the Fiscal Year 2011-12 Budget and 2011-16 CIP is necessary to increase the current fiscal year appropriation and update planned funding sources for latter phases of the Project.
