A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO SIGN AND EXTEND
THE SACRAMENTO ABANDONED VEHICLE SERVICE AUTHORITY AGREEMENT
FOR THE PURPOSE OF RECEIVING REIMBURSEMENT FOR THE COSTS OF
ABATING ABANDONED, UNREGISTERED AND INOPERABLE VEHICLES
IN THE CITY OF ELK GROVE

- WHEREAS, the City of Elk Grove joined the Sacramento County Abandoned Vehicle Service Authority in 2002 for the removal of local abandoned vehicles that are public nuisances or pose health or safety hazards; and
- WHEREAS, the current contract between the Sacramento Abandoned Vehicle Service Authority (SAVSA) and the City of Elk Grove to implement the Sacramento Abandoned Vehicle Abatement Plan was for a ten-year term, and is set to expire on April 30, 2012; and
- WHEREAS, Section 9250.7 of the California Vehicle Code allows counties and cities to establish Abandoned Vehicle Service Authorities and to impose a one dollar additional registration fee on all vehicles; and
- WHEREAS, the provisions of Sections 22710 and 9250.7 allow the City of Elk Grove to recover costs for vehicle abatement from the Sacramento Abandoned Vehicle Service Authority; and
- WHEREAS, the City of Elk Grove has an on-going program to remove abandoned vehicles through the Police Department and Code Enforcement Division; and
- **WHEREAS**, funds are needed to defray the costs of the City of Elk Grove's vehicle abatement efforts.
- NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to sign the Sacramento Abandoned Vehicle Service Authority agreement, in a form approved by the City Attorney, for the purpose of receiving reimbursement for the costs of abating abandoned, unregistered and inoperable vehicles in the City of Elk Grove.
