A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE **AUTHORIZING THE CITY MANAGER TO SUBMIT A GRANT APPLICATION TO THE** ALLSTATE FOUNDATION FOR A SAFE TEEN DRIVING / AWARENESS OF DISTRACTED DRIVING PROGRAM AND EXECUTE ALL DOCUMENTS NECESSARY TO RECEIVE UP TO \$20,000 IN ELIGIBLE GRANT FUNDING

WHEREAS, one of the core goals of the Allstate Foundation is to encourage teens to motivate other teens to be smart drivers and smart passengers to reduce the amount of teen-involved car accidents; and

WHEREAS, the Allstate Foundation has been provided funding to support safer communities since 1952; and

WHEREAS, one of City Council's goals is to grow and support safe, livable, and attractive neighborhoods; and

WHEREAS, there are no General Fund match requirements under this grant program.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to: 1) submit a grant application to the Allstate Foundation for a safe teen driving / awareness of distracted driving program; 2) subject to approval by the City Attorney, execute all contracts, reports, and other documents required for receiving grant funding pursuant to the terms and conditions of the Foundation; and 3) if awarded, amend the Police Department's revenue and expense budget in an amount equal to the grant award, not to exceed \$20,000.
