A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO RECEIVE FUNDS IN THE AMOUNT OF
\$12,000 FROM THE LIVERMORE POLICE DEPARTMENT FOR MOTORCYCLE
SAFETY AND ENFORCEMENT TRAINING PROVIDED BY THE ELK GROVE
POLICE DEPARTMENT AND AMEND THE ELK GROVE POLICE DEPARTMENT'S
BUDGET BY \$12,000

WHEREAS, the Livermore Police Department received grant funding from the California Office of Traffic Safety (OTS) to conduct motorcycle safety and enforcement training for its police officers; and

WHEREAS, the OTS grant received by the Livermore Police Department allows them to contract with POST (Police Officer Standards and Training) approved law enforcement agencies to provide motorcycle safety and enforcement training; and

WHEREAS, the Elk Grove Police Department personnel are POST approved and experienced with providing motorcycle safety and enforcement training; and

WHEREAS, the Livermore Police Department has agreed to reimburse the City of Elk Grove for all expenses incurred with providing motorcycle safety and enforcement training to their officers, including salary, benefits, and travel; and

WHEREAS, the City of Elk Grove welcomes opportunities to foster its relationships with neighboring law enforcement agencies and municipalities.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby adopts a resolution authorizing the City Manager to: 1) receive funds in the amount of \$12,000 from the Livermore Police Department for motorcycle safety and enforcement training provided by the Elk Grove Police Department; and 2) amend the Police Department's operating budget by \$12,000 to offset the costs of providing this service.
