A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AUTHORIZING THE CITY MANAGER TO ACCEPT ADDITIONAL GRANT FUNDING FROM THE U.S. DEPARTMENT OF JUSTICE DRUG ENFORCEMENT ADMINISTRATION FOR THE PURPOSE OF ERADICATING MARIJUANA CULTIVATION AND AMEND THE POLICE DEPARTMENT'S FISCAL YEAR 2011-12 BUDGET IN THE AMOUNT OF \$7,000, REFLECTING A TOTAL GRANT AWARD OF \$50,000

WHEREAS, in January 2012, the Elk Grove Police Department sought grant funding in the amount of \$43,000 from the U.S. Department of Justice to assist their Narcotics Team in investigating and eradicating illegal drug operations in the City of Elk Grove; and

WHEREAS, the U.S. Department of Justice Drug Enforcement Administration awarded the Elk Grove Police Department \$50,000 in grant funding, \$7,000 more than requested; and

WHEREAS, these grant funds will allow the Police Department to broaden its scope of work related to eradicating illegal drug operations; and

WHEREAS, this grant supports City Council's goal to grow and support safe, livable, attractive neighborhoods.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby adopts a resolution authorizing the City Manager to:

- Accept an additional \$7,000 in grant funding from the U.S. Department of Justice Drug Enforcement Administration for the purpose of eradicating illegal drug operations in the City of Elk Grove; and
- 2) Execute all related award documents required for receiving such funds pursuant to the terms and conditions of the U.S. Department of Justice; and
- 3) Amend the Police Department's Fiscal Year 2011-12 revenue and expense budget as follows:
