**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AMENDING THE FISCAL YEAR 2012-13 DEVELOPMENT SERVICES – PLANNING
DEPARTMENT BUDGET RELATED TO ENVIRONMENTAL REVIEW PROCESSING**

WHEREAS, pursuant to the California Environmental Quality Act (CEQA), all development projects must go through an environmental review process as part of the development application; and


WHEREAS, funding for the CEQA environmental review is fully covered by development applicants; and

WHEREAS, unexpected large development applications have been submitted to the Planning Department that far exceed the amounts budgeted.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby amends the Fiscal Year 2012-13 Planning Department Budget to reflect a revenue neutral increase in revenue and expenditure fund lines related to California Environmental Quality Act (CEQA) environmental review fees collected from new Development Applicants, as follows:


