WHEREAS, the City of Elk Grove desires to quitclaim its interest in the original property granted by the Elk Grove Unified School District prior to accepting the additional right-of-way for a larger bus turnout.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute and record a Quitclaim Deed to release any interest in Assessor's Parcel Number 125-0100-003 granted by the Elk Grove Unified School District.
