A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO ACCEPT PROGRAM FUNDING FROM
PETSMART CHARITIES TO IMPLEMENT A TWO-YEAR SPAY AND NEUTER
PROGRAM FOR FREE-ROAMING CATS AND AMEND THE POLICE
DEPARTMENT'S FISCAL YEAR 2012-13 BUDGET IN THE AMOUNT OF \$68.750

WHEREAS, the mission of Petsmart Charities is to improve the quality of life for all pets by creating and supporting programs that save the lives of free-roaming pets and promote healthy relationships between people and pets; and

WHEREAS, Petsmart Charities supports its mission by funding innovative and collaborative programs that save the lives of free-roaming pets; and

WHEREAS, the Elk Grove Police Department's Animal Control Division maintains an active, collaborative relationship with the Sacramento Society for the Prevention of Cruelty to Animals (SPCA) to ensure the humane treatment of free-roaming animals; and

WHEREAS, the Elk Grove Police Department and the Sacramento SPCA seeks to continue their collaborative relationship and implement an innovative program that will address the overpopulation of free-roaming cats; and

**WHEREAS**, Petsmart Charities has offered the Elk Grove Police Department \$68,750 in program funding to implement this innovative program; and

**WHEREAS**, this program supports City Council's goal to grow and support safe, livable, attractive neighborhoods.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby adopts a resolution authorizing the City Manager to:

- 1) Accept program funding from Petsmart Charities in the amount of \$68,750 for the purpose of implementing a spay and neuter program for free-roaming cats; and
- 2) Execute all related documents required for receiving such funds pursuant to the terms and conditions of Petsmart Charities; and
- 3) Amend the Police Department's revenue and expense budget as follows:
