**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO EXECUTE THE THIRD AMENDMENT TO
CITY OF ELK GROVE COMMUTER, FIXED ROUTE, ADA COMPLEMENTARY
PARATRANSIT AND DIAL-A-RIDE OPERATIONS AND MAINTENANCE
AGREEMENT WITH MV TRANSPORTATION, INC.**

WHEREAS, the City entered into a contract with MV Transportation Inc. for Commuter, Fixed Route, ADA Complementary Paratransit and Dial-A-Ride operations and Maintenance on August 28, 2009; and


WHEREAS, the City also entered into subsequent amendments including the First and Second Amendments to the contract; and

WHEREAS, City and MV staff have identified additional contract amendments that must be addressed by way of a Third Amendment; and

WHEREAS, the Third Amendment includes contract term modifications that include clarifying shelter maintenance responsibility, bus cleaning, cash collection, time points, computer aided dispatch system, dispatch service on weekend, Compressed Natural Gas credit to the City, and payment for additional services.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager, or her designee, to execute the Third Amendment, in substantially the form presented as approved by the City Attorney, to City of Elk Grove Commuter, Fixed Route, ADA Complementary Paratransit and Dial-A-Ride Operations and Maintenance Agreement with MV Transportation, Inc.


