A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AUTHORIZING THE CITY MANAGER TO ACCEPT GRANT FUNDING FROM THE SACRAMENTO URBAN AREA SECURITY INITIATIVE FOR THE PURCHASE OF SATELLITE AND MOBILE RADIOS AND AMEND FLEET SERVICES' FISCAL YEAR 2012-13 BUDGET IN THE AMOUNT OF \$10,909

WHEREAS, the Urban Area Security Initiative (UASI) is a federal program that provides financial assistance to address the planning, organization, equipment, training, and exercise needs of high-threat, high-density urban areas, and assists in building and sustaining capabilities to prevent, protect against, respond to, and recover from threats or acts of terrorism; and

WHEREAS, the Sacramento Regional Office of Homeland Security serves as the fiscal agent for the Sacramento UASI program, administering funds to local municipalities based on need and available funds; and

WHEREAS, the Sacramento UASI program has awarded the City of Elk Grove \$10,909 in grant funding to enhance their satellite and mobile radio capabilities; and

WHEREAS, the Sacramento UASI grant program requires a monetary match of 25% of the overall project cost of \$14,545 which is equal to \$3,636; and

WHEREAS, the match of \$3,636 can be funded from existing appropriations out of the Facilities & Fleet department; and

WHEREAS, the purchase of satellite and mobile radios will enhance Elk Grove's ability to communicate with local and outside agencies during a large scale emergency

WHEREAS, this initiative supports City Council's goal to grow and support safe, livable, attractive neighborhoods.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby adopts a resolution authorizing the City Manager to:

- 1) Accept grant funding from the Sacramento Urban Area Security Initiative in the amount of \$10,909 for the purchase of satellite and mobile radios; and
- Execute all related documents required for receiving such funds pursuant to the terms and conditions of the Sacramento Urban Area Security Initiative; and
- 3) Amend Fleet Services' revenue and expense budget as follows:
