WHEREAS, the Bulletproof Vest Partnership (BVP), created by the Bulletproof Vest Partnership Grant Act of 1998 is a U.S. Department of Justice initiative designed to provide a critical resource to state and local law enforcement; and

WHEREAS, the purpose of the Bulletproof Vest Partnership Grant Act is to protect the lives of law enforcement officers by helping states and units of local government equip their officers with armor vests; and

WHEREAS, the Elk Grove Police Department received a grant allocation from the U.S. Department of Justice Bulletproof Vest Partnership to support the purchase of bulletproof vests for its officers.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby adopts a resolution authorizing the City Manager to:

- 1) Accept a grant award from the U.S. Department of Justice for the purpose of supporting the purchase of bulletproof vests in the amount of \$2,438; and
- Take all necessary action and execute all related award documents required for receiving such funds pursuant to the terms and conditions of the U.S. Department of Justice; and
- 3) Amend the Police Department's Fiscal Year 2012-13 revenue and expense budgets as follows:
