A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE **AUTHORIZING THE CITY MANAGER TO ACCEPT AN APPROPRIATION FROM** THE STATE SUPPLEMENTAL LAW ENFORCEMENT SERVICES FUND IN THE AMOUNT OF \$250,752 AND INCREASE THE POLICE DEPARTMENT'S REVENUE **AND EXPENSE BUDGET BY \$250.752**

WHEREAS, the State Legislature has recently authorized the release of supplemental funding for frontline law enforcement under the State Supplemental Law Enforcement Services Fund (SLESF); and

WHEREAS, the amount appropriated for the Elk Grove Police Department is \$250,752 for a two year period; and

WHEREAS, funds under this program must be used in accordance with Government Code Sections 30061 and 30063; and

WHEREAS, the Police Department has determined an expenditure plan that supports police operations and services for the City of Elk Grove; and

WHEREAS, the SLESF requires the Police Department's expenditure plan under this program be approved by resolution.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to: 1) accept an appropriation from the State Supplemental Law Enforcement Services Fund (SLESF) of \$250,752; 2) increase the Police Department's revenue and expense budget in the amount of \$250,752; and 3) expend funds in accordance with Government Code Sections 30061 and 30063 mandating these funds be used for frontline police operations and services.
