

**RESOLUTION NO. 2013-3**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
AUTHORIZING THE CITY MANAGER TO PROVIDE EACH OF THE SEVEN HIGH  
SCHOOLS A \$500 SPONSORSHIP THAT GOES DIRECTLY TO THE GRAD NIGHT  
EXPENSES, IN A TOTAL AMOUNT NOT TO EXCEED \$3,500**

**WHEREAS**, the City of Elk Grove was recently approached to sponsor the Cosumnes Oaks High School 2012 sober grad night event; due to the nature of this request, if the City were to sponsor one local grad night, it would be prudent to sponsor all local grad night events; and


**WHEREAS**, the City recognizes the value of grad night events to students, teachers, parents and local law enforcement; the implementation of a grad night event is a typical strategy to keep students away from the use of alcohol and drugs on their graduation night; and

**WHEREAS**, the cost to support the local grad nights would be a total of \$3,500 (\$500 for seven schools) and funds are available and programmed within the City Council's Fiscal Year 2012-13 budget.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Manager to provide each of the seven high schools a \$500 sponsorship that goes directly to the grad night expenses, which include: event promotion, decorations, food/beverages, activities and games. Those schools include: 1) Cosumnes Oaks, 2) Elk Grove, 3) Franklin, 4) Laguna Creek, 5) Monterey Trail, 6) Pleasant Grove, 7) and Sheldon\* High Schools.

\*Sheldon High School is immediately adjacent to the city limits, and its attendance area includes neighborhoods within the City.


