A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AUTHORIZING THE CITY MANAGER TO SUBMIT A SIGNED RESOLUTION, AUTHORIZED AGENT FORM, ASSURANCES, AND FINANCIAL MANAGEMENT FORMS TO ALLOW FOR THE CALIFORNIA DEPARTMENT OF EMERGENCY MANAGEMENT TO AWARD \$500,000 OF PROPOSITION 1B BONDS FOR THE CONSTRUCTION OF A SECURE EMPLOYEE PARKING AREA ON THE NORTH SIDE OF THE CORPORATION YARD

WHEREAS, the City of Elk Grove operates a comprehensive transit system; and

WHEREAS, the City has been awarded Proposition 1B Transit Safety and Security Grant Program funding to implement and support transit capital projects; and

WHEREAS, the City of Elk Grove is authorized to request \$500,000 towards the construction of corporation yard security improvements; and

WHEREAS, the City of Elk Grove will request allocation of the funds through the California Emergency Management Agency; and

WHEREAS, it is in the City's best interest to have improved transit employee security and an improved staging site for disaster operations.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove authorizes the City Manager to execute grant award documentation including but not limited to the resolution, authorized agent form, assurances and financial management forms to the California Emergency Management Agency for Proposition 1B Safety and Security Funds for the construction of a secure employee parking area on the north side of the Corporation Yard.
