RESOLUTION NO. 2013-44

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE APPROVING IDENTIFIED STREETS FOR SPEED CONTROL MEASURES AND DIRECTING STAFF TO PROCEED WITH DESIGN AND CONSTRUCTION FOR THE TOP RANKED STREETS

WHEREAS, the City of Elk Grove wishes to manage residential street speeds utilizing a systematic approach for the entire City; and

WHEREAS, the City has adopted a Speed Control Program which contains guidelines to qualify and prioritize streets for installation of speed control measures; and

WHEREAS, the City has conducted meetings with the residents and obtained consensus from the residents on the proposed speed control measures on seven qualified streets; and

WHEREAS, the City has balloted residents on seven qualified streets to ensure their support of the proposed speed control measures; and

WHEREAS, the residents on the following seven streets have returned at least 50 percent of the ballots and two-thirds of the returned ballots are in support of the proposed speed control measures; and

WHEREAS, the California Environmental Quality Act (Section 21000 et seq. of the Public Resources Code, herein after CEQA) requires that cities consider the environmental consequences of their actions before approving a project; and

WHEREAS, Section 15301 (Existing Facilities) of the State CEQA Guidelines (Chapter 3 of Division 6 of Title 14 of the California Code of Regulations) provides an exemption from CEQA for projects involving the minor alteration of existing public or private facilities when the alteration involves negligible or no expansion of an existing use.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby:

- 1) Finds that the proposed implementation of traffic calming devices is exempt from environmental review pursuant to Section 15301 of the CEQA Guidelines, which applies to the minor alteration of existing public or private facilities when the alteration involves negligible or no expansion of an existing use; and
- 2) Approves the streets identified above for the design of speed control measures; and
- 3) Directs staff to proceed with design and preparation of construction documents for speed control measures on the top ranked streets within Council approved budgeted funds in the Capital Improvement Program and the adopted budget.
