A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AUTHORIZING THE CITY MANAGER TO ACCEPT A FUNDING ALLOTMENT IN THE AMOUNT OF \$365,332 FROM THE STATE OF CALIFORNIA DEPARTMENT OF GENERAL SERVICES FOR THE PURCHASE OF 9-1-1 COMMUNICATIONS EQUIPMENT AND AMEND THE POLICE DEPARTMENT'S REVENUE AND EXPENSE BUDGET IN THE AMOUNT OF \$365,332

WHEREAS, the State of California Department of General Services manages the State's emergency communications system and provides funding to approved Public Safety Answering Point agencies for 9-1-1 equipment and services: and

WHEREAS, the Elk Grove Police Department's Emergency Dispatch Center is a State of California approved Public Safety Answering Point agency and is eligible for \$560,000 in funding; and

WHEREAS, the Elk Grove Police Department's Emergency Dispatch Center desires to purchase 9-1-1 communications equipment in the amount of \$365,332 utilizing State allocated 9-1-1 funding.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby adopts a resolution authorizing the City Manager to: 1) accept a funding allotment in the amount of \$365,332 from the State of California Department of General Services; and 2) amend the Police Department's revenue and expense budget in the amount of \$365,332 as follows:
