A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
ACCEPTING THE ELK GROVE BOULEVARD AT ELK GROVE-FLORIN ROAD BUS
TURNOUT PROJECT AS COMPLETE AND AUTHORIZING THE CITY ENGINEER TO
PREPARE A NOTICE OF COMPLETION AND THE CITY CLERK TO FILE THE NOTICE
OF COMPLETION WITH THE SACRAMENTO COUNTY RECORDER; AND
AUTHORIZING THE CITY ENGINEER TO APPROVE CHANGE ORDERS NOT-TOEXCEED \$30,000

WHEREAS, on January 9, 2013 the City Council authorized the award of a construction contract to F. Loduca Company for the Elk Grove Boulevard at Elk Grove-Florin Road Bus Turnout Project (Capital Improvement Project ID WTE003) (the "Project"); and

WHEREAS, the Project constructed a bus turnout at the existing bus stop in the northwest corner of the intersection of Elk Grove Boulevard and Elk Grove-Florin Road; and

WHEREAS, F. Loduca Company has completed the work for the Project; and

WHEREAS, during construction F. Loduca Company encountered unsuitable sub-grade material that required removal, which is to be paid for as extra work pursuant to the construction contract; and

WHEREAS, authorization of additional change order contingency for the City Engineer in the amount of \$14,837.30 is needed to cover the extra work, for a total not-to-exceed contingency amount of \$30,000; and

WHEREAS, if no liens or claims have been filed within thirty-five (35) days of filing the Notice of Completion, the retained payment funds and any remaining amount due will be released to F. Loduca Company.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby accepts the Elk Grove Boulevard at Elk Grove-Florin Road Bus Turnout Project as complete.

BE IT FURTHER RESOLVED that the City Council of the City of Elk Grove hereby:

- 1) Authorizes the City Engineer to approve change orders not-to-exceed \$30,000.
- 2) Authorizes the City Engineer to prepare a Notice of Completion and the City Clerk to file the Notice of Completion for the Project with the Sacramento County Recorder.
