WHEREAS, on July 11, 2012 the City Council authorized the award of a construction contract to Procida Landscape, Inc. to construct the Median Landscape Enhancement Project Willard Parkway – Elk Grove Boulevard (Capital Improvement Project ID PT0110) (Project); and

WHEREAS, the Project renewed groundcover and street tree landscaping to portions of the roadway medians on Elk Grove Boulevard between Franklin Road and State Route 99; and

WHEREAS, the Project also renewed the groundcover landscaping within the medians on Willard Parkway between Blossom Ridge Road and Matina Court and included tree replacements and pruning; and

WHEREAS, the Project also included major irrigation system repairs and installation of new irrigation; and

WHEREAS, Procida Landscape, Inc. has completed the work for the Project; and

WHEREAS, if no liens or claims have been filed within thirty-five (35) days of filing the Notice of Completion, the retained payment funds and any remaining amount due will be released to Procida Landscape, Inc.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby accepts the Median Landscape Enhancement Project Willard Parkway – Elk Grove Boulevard as complete.

BE IT FURTHER RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Engineer to prepare a Notice of Completion and the City Clerk to file the Notice of Completion for the Project with the Sacramento County Recorder.
