A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AMENDING THE FISCAL YEAR 2013-14 BUDGET FOR SHELDON COMMERCIAL AMENDMENTS PHASE ONE

WHEREAS, the City of Elk Grove, in adopting the City's first General Plan in 2003, identified the Sheldon Commercial (Old Town Sheldon) area as part of the City's rural community and directed subsequent development of a Special Planning Area; and

WHEREAS, the City Council adopted special standards and guidelines for the Sheldon Commercial area in 2004 (Supplemental Design Guidelines), 2005 (Ordinance No. 1-2005) and 2006 (Zoning Code); and

WHEREAS, the property owners in the Sheldon Commercial area communicated concerns to the City Council earlier this year with a few of the use and development restrictions in their area; and

WHEREAS, the City Council, at its September 11, 2013 meeting, has directed staff to proceed with public outreach and amendments to the Sheldon Commercial use and development regulations as appropriate; and

WHEREAS, the costs associated with undertaking this work had not previously been programmed within the Fiscal Year 2013-14 budget; and

WHEREAS, the City Council desires to provide initial funding for the effort during Fiscal Year 2013-14.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby amends the Fiscal Year 2013-14 Budget, to appropriate \$50,000 from the General Fund contingency account and increase Development Services Fund appropriations as follows:
