**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AMENDING THE FISCAL YEAR 2013-14 BUDGET FOR MASTER PLANNING OF
THE SOUTHEAST POLICY AREA TO PROVIDE FUNDING FOR PREPARATION OF
IMPLEMENTAITON PROGRAMS**

WHEREAS, the City of Elk Grove, in adopting the City's first General Plan in 2003, identified the Southeast Policy Area as an area for future growth; and

WHEREAS, policies in the City's General Plan call for the preparation of a master plan for the area prior to the consideration and approval of specific development projects; and

WHEREAS, in Fiscal Year 2011-12, the City Council set aside funds to explore the possibility of preparation of a master plan as a City project; and


WHEREAS, the City Council, at its July 27, 2012 meeting directed staff to prepare a master plan for the development of the Southeast Policy Area; and

WHEREAS, the City Council has determined it necessary to prepare implementation programs for the successful development of the Southeast Policy Area.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby amends the Fiscal Year 2013-14 Annual Budget to transfer \$420,000 from General Fund – Reserves by authorizing the following budget increases:
