

RESOLUTION NO. 2014-82

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY ENGINEER TO APPROVE CHANGE ORDERS NOT-TO-
EXCEED \$200,000 FOR THE ELK GROVE-FLORIN ROAD AND EAST STOCKTON
BOULEVARD INTERSECTION REALIGNMENT PROJECT (PT0085)**

WHEREAS, the Elk Grove-Florin Road and East Stockton Boulevard Intersection Realignment Project (PT0085) (Project) will realign the intersection of Elk Grove-Florin Road with East Stockton Boulevard and install a traffic signal to improve traffic flow; and

WHEREAS, the Elk Grove-Florin Road and East Stockton Boulevard Intersection Realignment Project is included in the approved 2013-18 Capital Improvement Program and is budgeted with funds in the approved Fiscal Year 2013-14 Budget; and

WHEREAS, the California Environmental Quality Act (Section 21000 et seq. of the Public Resources Code, herein after CEQA) requires that cities consider the environmental consequences of their actions before approving a project; and

WHEREAS, on August 28, 2013, the City Council adopted the CEQA findings that the Project is exempt from CEQA pursuant to State CEQA Guidelines Section 15301; and


WHEREAS, an invitation to bid was duly advertised on October 3, 2013, bids were opened on November 5, 2013, and a construction contract was awarded to Sierra National Construction; and

WHEREAS, Construction work is underway and contemplated change orders will exceed the available authorized construction contract contingency; and

WHEREAS, additional change order authority will be needed to complete the planned work.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Engineer to approve change orders not-to-exceed \$200,000.




