

**RESOLUTION NO. 2014-166**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
AUTHORIZING THE CITY ENGINEER TO APPROVE CHANGE ORDERS NOT-TO-  
EXCEED \$35,000 FOR THE LAGUNA CREEK WEIR REPAIR, EAST OF LEWIS  
STEIN PROJECT (WDR005)**

**WHEREAS**, the Laguna Creek Weir Repair Project, east of Lewis Stein, (WDR005) (Project) will construct a concrete cut-off wall to prevent future erosion and repair the existing erosion damage caused by runoff flowing between Elk Grove Creek and the bypass channel of Laguna Creek; and

**WHEREAS**, the Project is included in the approved Fiscal Year 2014-19 Capital Improvement Program and is budgeted with funds in the approved Fiscal Year 2014-15 Budget; and

**WHEREAS**, an invitation to bid was duly advertised on February 24, 2014, bids were opened on April 3, 2014, and a construction contract was awarded to Thurnder Mountain Enterprises, Inc; on May 14, 2014; and


**WHEREAS**, pursuant to Section 15301(b) (Existing Facilities) of the State CEQA Guidelines (Chapter 3 of Division 6 of Title 14 of the California Code of Regulations) the project was found exempt from CEQA when it was awarded no; and

**WHEREAS**, Construction work is underway and contemplated change orders will exceed the available authorized construction contract contingency; and


**WHEREAS**, additional change order authority will be needed to complete the planned work.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Engineer to approve change orders not-to-exceed \$35,000.




