**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO SUBMIT AN ALLOCATION REQUEST FOR
FISCAL YEAR 2014-15 PROPOSITION 1B – PUBLIC TRANSPORTATION,
MODERNIZATION, IMPROVEMENT, AND SERVICE ACCOUNT (PTMISEA) FUNDS, IN
THE AMOUNT OF \$1,741,330, TO THE SACRAMENTO AREA COUNCIL OF
GOVERNMENTS (SACOG) FOR THE PURCHASE OF
THREE (3) REPLACEMENT BUSES**

WHEREAS, the City of Elk Grove operates a comprehensive transit system; and

WHEREAS, the Sacramento Area Council of Governments (SACOG) the Proposition 1B – Public Transportation Modernization, Improvement, and Service Enhancement Account (PTMISEA) regional funding program to implement and support transit capital projects; and


WHEREAS, pursuant to SACOG's PTMISEA Expenditure Plan, the City of Elk Grove is authorized to request \$1,741,330 of available Fiscal Year (FY) 2014-15 PTMISEA regional funds for the replacement of three (3) transit buses; and

WHEREAS, it is in the City's best interest to have a transit fleet size needed to sustain current levels of transit service in the City to meet transit needs.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove authorizes the City Manager to submit an allocation request for FY 2014-15 Proposition 1B – Public Transportation, Modernization, Improvement, and Service Enhancement Account (PTMISEA) funds, in the amount of \$1,741,330, to the Sacramento Area Council of Governments (SACOG) for the purchase of three (3) replacement buses.

NOW, THEREFORE, BE IT FURTHER RESOLVED that the City Council of the City of Elk Grove, authorizes the City Manager to execute any necessary documents and make any necessary budget adjustments to receive these funds upon allocation at any level up to the requested amount of \$1,741,330.


