**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO EXECUTE A THIRD CONTRACT
AMENDMENT WITH FRANKLIN RANCH PET HOSPITAL FOR CANINE
VETERINARY CARE IN THE AMOUNT OF \$75,000; TOTAL CONTRACT
COMPENSATION INCLUDING ALL AMENDMENTS SHALL NOT EXCEED \$124,500**

WHEREAS, the Elk Grove Police Department has seven (7) canine officers that require veterinary care for their general health and service to the Police Department; and

WHEREAS, staff publicly announced a Request for Proposal (RFP), seeking the most qualified and experienced veterinarian care facility necessary for routine and emergency care, while ensuring the City is receiving the best value; and

WHEREAS, Franklin Ranch Pet Hospital was the only respondent to the RFP; and

WHEREAS, Franklin Ranch Pet Hospital is the City's current veterinary care provider, and has provided excellent care and service for more than nine (9) years.


NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute a third contract amendment with Franklin Ranch Pet Hospital for canine veterinary care in the amount of \$75,000; total contract compensation including all amendments shall not exceed \$124,500.
