

RESOLUTION NO. 2014-272

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
APPROVING AN UPDATED PARKING VIOLATION FINE SCHEDULE WITH
CHANGES TO CALIFORNIA VEHICLE CODE SECTION 4000(a) EXPIRED
REGISTRATION AND CALIFORNIA VEHICLE CODE 5200 DISPLAY OF PLATES**

WHEREAS, California Vehicle Code (CVC) section 40203.5 requires parking penalties to be established by the governing body of the jurisdiction where the notice of violation is issued; and

WHEREAS, the current City of Elk Grove Parking Violation Fine Schedule was adopted by the City Council on August 27, 2014, through Resolution No. 2014-190 and

WHEREAS, the Uniform Bail and Penalty Schedule determines the distribution of collected fines for traffic violations; and

WHEREAS, based on the Uniform Bail and Penalty Schedule, the Elk Grove Parking Violation Fine Schedule should be updated to reflect current fines applicable to violations of CVC 4000(a) Expired Registration and CVC 5200 Display of Plates; and

WHEREAS, with the exception to the updated fines for violations of CVC 4000(a) and CVC 5200, all other fines listed on the Parking Fine Schedule shall remain unchanged.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby adopts an updated parking violation fine schedule, attached hereto as Exhibit A and incorporated herein, to reflect an update to the fines applicable to violations of CVC 4000(a) and CVC 5200.
