

RESOLUTION NO. 2015-226

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
APPOINTING LYNDON HAWKINS TO A FOUR YEAR TERM AS THE CITY OF ELK  
GROVE MEMBER REPRESENTATIVE ON THE SACRAMENTO-YOLO MOSQUITO &  
VECTOR CONTROL DISTRICT'S BOARD OF TRUSTEES**

**WHEREAS**, in 1915 the California Legislature adopted the "Mosquito Abatement Act" to help protect people from health risks associated with mosquitoes, providing the basis for creating Mosquito Abatement Districts throughout the state; and

**WHEREAS**, the Sacramento County-Yolo County Mosquito Abatement District was formed on June 18, 1946, subsequently renamed the Sacramento-Yolo Mosquito & Vector Control District in July of 1990; and

**WHEREAS**, upon incorporation on July 1, 2000, the City of Elk Grove became eligible to have a Board of Trustees Member representative to the Sacramento-Yolo Mosquito & Vector Control District, pursuant to California Health and Safety Code section 2021(d); and

**WHEREAS**, Lyndon Hawkins was appointed to represent the City of Elk Grove on the Sacramento-Yolo Mosquito & Vector Control District Board of Trustees initially on December 5, 2001, and subsequently on December 17, 2003, October 24, 2007, and October 26, 2011; and

**WHEREAS**, Mr. Hawkins' current appointment expires on December 31, 2015, after a third, four-year term; and

**WHEREAS**, Mr. Hawkins has confirmed he wishes to continue to represent the City of Elk Grove in the capacity of a Board of Trustees Member representative to the Sacramento-Yolo Mosquito & Vector Control District, and he continues to meet all qualification requirements under California Health and Safety Code section 2022.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby appoints Lyndon Hawkins as the City of Elk Grove Board of Trustees Member representative to the Sacramento-Yolo Mosquito & Vector Control District to serve a four (4) year term expiring December 31, 2019.




