

RESOLUTION NO. 2015-234

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
CANCELLING THE EXISTING STREET MAINTENANCE ASSESSMENT ON APNS
115-0150-071-0000 AND 132-2390-004-0000; ABANDONING ANNEXATION NO. 11
OF STREET MAINTENANCE DISTRICT NO. 1, ZONE 5-H; AND DECLARING ITS
INTENT TO LEVY STREET MAINTENANCE ASSESSMENTS IN ZONE 5-I (LAGUNA
RIDGE AREA), ANNEXATION NO. 12**

WHEREAS, the City Council (the "City Council") of the City of Elk Grove (the "City") has determined to undertake proceedings pursuant to the Benefit Assessment Act of 1982, being California Government Code sections 54703 *et seq.* (the "Act"), to levy assessments to finance the costs of maintaining streets and roads and to equitably distribute the costs among benefited landowners in developing areas; and

WHEREAS, the City Council annexed the the properties identified as Sacramento County Assessor Parcel Numbers 115-0150-071-0000 and 132-2390-004-0000 into Street Maintenance District 2-G in error, and by this Resolution seeks to cancel that incorrect assessment; and

WHEREAS, City staff has determined that Annexation No. 11 of Street Maintenance District No. 1, Zone 5-H should not have been recommended for annexation and therefore staff now recommends the proceedings to complete annexation be abandoned by the City Council; and

WHEREAS, the City Council by its Resolution No. 2003-82, adopted April 16, 2003, levied assessments to finance the costs of maintaining streets and roads on property located within the boundaries of an area referred to therein as City of Elk Grove Street Maintenance District No. 1 (the "District"); and

WHEREAS, City staff have prepared and filed with the City Clerk a Supplemental Engineer's Report (Supplement No. 12), which supplements the Engineer's Report for Zone 5 of the District originally submitted on August 24, 2005, and supplemented by:

1. Supplement No. 1 on October 26, 2005;
2. Supplement No. 2 on August 22, 2007;
3. Supplement No. 3 on October 24, 2007;
4. Supplement No. 4 on August 26, 2009;
5. Supplement No. 5 on February 13, 2013;
6. Supplement No. 6 on April 24, 2013
7. Supplement No. 7 on July 24, 2013
8. Supplement No. 8 on March 12, 2014
9. Supplement No. 9 on March 26, 2014
10. Supplement No. 10 on January 14, 2015;
11. Supplement No. 11 on September 23, 2015 (*hereby abandoned*) (collectively, the "Engineer's Report"); and

WHEREAS, in accordance with the Act, the Engineer's Report as supplemented by Supplement No. 12 proposes the amount of assessments to be levied on certain additional property described therein (referred to herein as the "annexed property"), which would be deemed a part of the District if the assessments are levied; and

WHEREAS, the annexed property is located within a zone of benefit referred to as "Zone 5 (Laguna Ridge Area)"; and

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Elk Grove as follows:

1. **Recitals**. The above recitals are true and correct.
2. **Deannexation from Street Maintenance District No. 1, Zone 2-G and Cancellation of Assessment**. On July 22, 2015, the APNs, 115-0150-071-0000 and 132-2390-004-0000 were incorrectly approved at Public Hearing for annexation into Street Maintenance District No. 1, Zone 2-G. Zone 2 of the Street Maintenance District No. 1 was the incorrect zone for APNs 115-0150-071-0000 and 132-2390-004-0000. A Notice of Cancellation of Assessment from Zone 2 will be filed against APNs 115-0150-071-0000 and 132-2390-004-0000 within 30 days of the City Council's adoption of this resolution.
3. **Abandonment of Proceedings**. Due to the incorrect ballot issued to the landowner after the September 23, 2015, filing of the resolution of intent to annex property into Street Maintenance District No. 1, Zone 5-H, the City Council hereby orders that all proceedings of Annexation No. 11 of Street Maintenance District No. 1, Zone 5-H, be abandoned, and are hereby replaced by proceedings of annexation of territory into Street Maintenance District No. 1, Zone 5-I, Annexation No. 12.
4. **Approval of Supplement No. 12**. The City Council hereby approves Supplement No. 12, which incorporates by reference the Engineer's Report. The Engineer's Report as supplemented by Supplement No. 12 sets forth a full and detailed description of the costs financed by the assessments, the parcels to be assessed, and the proposed assessments upon assessable lots and parcels of the annexed property. The Engineer's Report and Supplement No. 12 are on file in the City Clerk's office, 8401 Laguna Palms Way, Elk Grove, California, and are available for review by any interested member of the public during normal business hours.
5. **Recording of Notice**. The City Clerk is directed to record with the Sacramento County Recorder's office: (1) a Notice of Cancellation of Assessment; and (2) a copy of this Resolution of Abandonment and accompanying Certificate of the City Clerk, abandoning the Proceedings of Annexation No. 11 of Street Maintenance District No. 1, Zone 5-H, pursuant to Section 3117 of the California Street and Highways Code.


6. **Notice of Public Hearing**. The City Clerk is directed to give notice of the public hearing by:

- a. publishing a notice in the form attached hereto as Exhibit A once a week for two successive weeks in *The Elk Grove Citizen*. The first publication shall be no later than November 25, 2015, and publication shall be completed by December 9, 2015; and
- b. posting a notice in the form attached hereto as Exhibit A in at least three public places within the City; and
- c. mailing a notice and ballot in substantially the form attached hereto as Exhibit B to the record owners of each identified parcel within the annexed property. Mailing shall be completed by November 20, 2015.

7. **Public Hearing**. On Wednesday, January 13, 2016 at 6:00 p.m., or as soon thereafter as the matter may be heard, at City Hall, 8400 Laguna Palms Way, Elk Grove, California, the City Council shall hold a public hearing on the Engineer's Report as supplemented by Supplement No. 12 and the question of the levy of the proposed assessments.


8. **Effective Date**. This resolution shall take effect from and after the date of its passage.



SUBJECT: Street Maintenance Assessments (additions to City of Elk Grove Street Maintenance District No. 1, Zone 5-I (Laguna Ridge Area) Ballot Proceeding

The purpose of this notice is to provide you with information about the assessment ballot proceeding being conducted by the City of Elk Grove and its effect on real property that you own. Please be advised of the following:

- A hearing will be held on January 13, 2016, at 6:00 p.m., or as soon thereafter as the matter may be heard at the City Hall, 8400 Laguna Palms Way, Elk Grove, California.
- The reason for the assessment is to fund the maintenance and operation of streets serving property proposed to be added to the City of Elk Grove Street Maintenance District No. 1 (the "District").
- The proposed annual assessment is \$115.76 per single family residential unit, and \$81.03 for each multi-family unit, for each parcel with respect to which an application for a building permit has been filed. Such assessment may be increased each year after fiscal year 2015-16 based upon the increase in the Engineering News Record Construction Cost for the San Francisco Bay Area over the prior year. Your property is expected to have 976 single family residential units at buildout, which would result in a total assessment of \$112,981.76 (plus inflation adjustments) at that time. Your property is also expected to have 200 multi-family residential units at buildout, which would result in a total assessment of \$16,206.00 (plus inflation adjustments) at that time.
- The total amount chargeable to all the property proposed for assessment in this proceeding at buildout would be \$129,187.76 (plus inflation adjustments).

- Assessment duration: in perpetuity.
- How the assessment was calculated: The assessment is apportioned on all assessable lots or parcels proposed for assessment in proportion to the estimated benefits to be received by each lot or parcel. Benefit to any parcel is in proportion to its number of EDUs when developed. The total estimated costs for operation and maintenance of streets that serve the property is allocable among all parcels in proportion to each parcel's expected EDUs. For additional detail, see the Engineer's Report and relevant supplements.

Enclosed with this notice, you will find an assessment ballot. Please follow the directions on the assessment ballot to express your view on the proposed assessment.

1. Ballots may be mailed or delivered to the City Clerk at any time, but **MUST** be received not later than the conclusion of the public hearing described above. At any time prior to the conclusion of the public hearing, you may withdraw your ballot and submit a changed or new ballot in place of the ballot previously submitted.

2. At the conclusion of the public hearing, the City Clerk will tabulate the ballots received, including those received during the public hearing.

3. The City will not impose the assessment if there is a majority protest. A majority protest exists if, upon the conclusion of the hearing, ballots submitted in opposition to the assessment exceed the ballots submitted in favor of the assessment. Ballots shall be weighted according to the proportional financial obligation of the affected property.


