A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AUTHORIZING THE CITY MANAGER TO APPLY FOR GRANT FUNDING FROM THE CALIFORNIA OFFICE OF TRAFFIC SAFETY TO CONTINUE IMPLEMENTATION OF "BEFORE THE IMPACT" A DRIVING SAFETY PROGRAM IN AN AMOUNT NOT-TO-EXCEED \$120,000 AND INCREASE THE POLICE DEPARTMENT'S REVENUE AND EXPENSE BUDGET BY THE ACTUAL AMOUNT RECEIVED

WHEREAS, the California Office of Traffic Safety provides grant funding to encourage law enforcement agencies to work together on countywide efforts to discourage those who may engage in risky driving behaviors; and

WHEREAS, previously, the Sacramento District Attorney's Office received grant funding from the California Office of Traffic Safety to partner with the Elk Grove Police Department to provide community awareness and education to reduce the number of fatalities related to teenage and adult drivers; and

WHEREAS, the Elk Grove Police Department will now seek grant funding directly from the California Office of Traffic Safety to continue delivering "Before the Impact" a driving safety education and awareness program for teens and adults.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to: 1) apply for grant funding from the California Office of Traffic Safety to continue implementation of "Before the Impact," a driving safety education and awareness program, in an amount not to exceed \$120,000: and 2) execute all contracts, reports, and other documents required for receiving such funds pursuant to the terms and conditions of the California Office of Traffic Safety; and 3) increase the Police Department's revenue and expense budget equal to the amount awarded and expended each fiscal year until the total grant award has been expended.
