

**RESOLUTION NO. 2016-023**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
AUTHORIZING THE CITY MANAGER TO EXECUTE A THREE YEAR CONTRACT  
WITH AN OPTIONAL TWO YEAR EXTENSION, WITH PROFESSIONAL  
LANDSCAPING SOLUTIONS INC. OF SACRAMENTO TO PROVIDE LANDSCAPING  
SERVICES FOR CITY FACILITIES IN AN AMOUNT NOT-TO-EXCEED \$155,000**

**WHEREAS**, the City of Elk Grove's Facilities Services Division maintains City facilities; and


**WHEREAS**, in January 2016 the City conducted a formal request for proposals to seek economies of scale and thereby complied with the competitive bid requirements of Elk Grove Municipal Code Chapter 3.42 regarding contracts and purchasing; and

**WHEREAS**, Professional Landscape Solutions Inc. of Sacramento met all of the criteria in the request for proposal and was determined to be the lowest responsive, responsible bidder to the City; and

**WHEREAS**, Facilities Services has sufficient funding identified in its Fiscal Year 2015-16 operating budget for this service.


**NOW, THEREFORE BE IT RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute a three-year contract with Professional Landscape Solutions Inc. of Sacramento with an optional two-year extension in an amount not-to-exceed \$155,000 for landscaping services of City facilities.




