A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE ADOPTING THE SECOND AMENDMENT TO THE NEIGHBORHOOD STABILIZATION PROGRAM (NSP) ACTION PLAN

- WHEREAS, on November 12, 2008, the City of Elk Grove (City) adopted a Neighborhood Stabilization Program (NSP) Substantial Amendment (NSP Action Plan) in order to receive funds under Title III of Division B of the Housing and Economic Recovery Act of 2008; and
- WHEREAS, on March 25, 2009, the City adopted the first amendment to the NSP Action Plan, adding a new activity and adjusting existing activity budgets; and
- WHEREAS, the U.S. Department of Housing and Urban Development (HUD) is the federal agency that promulgates regulations and oversees the administration of the NSP funds, and approved the NSP Action Plan and Amendment #1; and
- **WHEREAS**, since the adoption of the NSP Action Plan, the City has completed the activities proposed within it; and
- **WHEREAS**, the use of NSP funds has resulted in significant current and anticipated income, which may be used in support of NSP-eligible activities, subject to NSP regulations; and
- WHEREAS, the City wishes to undertake two activities not previously detailed in the NSP Action Plan and also wishes to allocate additional funding to administer the new activities; and
- WHEREAS, a public notice announcing the availability of the NSP Action Plan Amendment #2 and the 15-day public comment period was published online and in the Elk Grove Citizen on February 19, 2016; and
- **WHEREAS**, the 15-day public comment period has closed and the second amendment to the NSP Action Plan has been considered by the Elk Grove City Council.
- **NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby:
 - Approves the adoption of the second amendment to the NSP Action Plan;
 and
 - 2) Authorizes the City Manager, or designee, to execute and file the amended NSP Action Plan, along with any required certifications and forms, to HUD, and to make minor changes to those documents where necessary.
