A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE DISPENSING WITH COMPETITIVE BIDDING PER THE ELK GROVE MUNICIPAL CODE AND AUTHORIZING THE CITY MANAGER TO EXECUTE A THREE (3) YEAR CONTRACT WITH UNIVERSITY ENTERPRISES, INC., FOR STUDENT ASSISTANT SERVICES, NOT TO EXCEED \$80,000 PER YEAR [FOR A TOTAL COMPENSATION AMOUNT OVER THE TERM OF THE CONTRACT NOT TO EXCEED \$240,000]

WHEREAS, the City works with University Enterprises, Inc. to offer student assistant services; and

WHEREAS, the City Council of the City of Elk Grove would like to offer student assistants to provide valuable experience to students in our community; and

WHEREAS, the City Council of the City of Elk Grove recognizes that the student assistant program is a cost effective way to offer assistance in developing new programs for the City; and

WHEREAS, for the reasons presented, it is in the best interest of the City to dispense with the formal competitive bidding procedure pursuant to Elk Grove Municipal Code Section 3.42.180(B)(3) for the services described herein.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby determines that the compliance with formal competitive bidding procedure is not in the best interest of the City for the services described herein and authorizes the City Manager to execute the necessary documents to enter into a three (3) year contract with University Enterprises, Inc., for student assistant services, not to exceed \$80,000 per year [for a total compensation amount over the term of the contract not to exceed \$240,0001.
