A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE FINDING THE ELK GROVE-FLORIN ROAD SIDEWALK INFILL AT STRAWBERRY CREEK PROJECT (WAC016) EXEMPT FROM THE CALIFORNIA ENVIRONMENTAL QUALITY ACT; AUTHORIZING THE CITY MANAGER TO EXECUTE A CONSTRUCTION CONTRACT WITH MARTIN GENERAL ENGINEERING, INC. FOR THE ELK GROVE-FLORIN ROAD SIDEWALK INFILL AT STRAWBERRY CREEK PROJECT (WAC016) IN THE AMOUNT OF \$115,997; AUTHORIZING THE CITY ENGINEER TO APPROVE CHANGE ORDERS NOT-TO-EXCEED \$20,000; AND AUTHORIZING THE CITY MANAGER TO EXECUTE A CONSTRUCTION CONTRACT WITH THE SECOND LOWEST BIDDER, R&R PACIFIC CONSTRUCTION, IF MARTIN GENERAL ENGINEERING, INC. DOES NOT MEET FILING OBLIGATIONS

WHEREAS, the Elk Grove-Florin Road Sidewalk Infill at Strawberry Creek Project (WAC016) (the "Project") will construct approximately 260 feet of concrete curb and gutter, 125 feet of concrete sidewalk and 135 feet of AC path to connect existing sidewalks at the north and south ends of the project. The work is adjacent to Strawberry Creek where it crosses under Elk Grove-Florin Road. Construction will include excavation, grading, concrete work, and underground storm drain; and

WHEREAS, the Project is included in the approved Fiscal Year 2015-20 Capital Improvement Program and is budgeted with funds in the approved Fiscal Year 2015-16 Budget; and

WHEREAS, the California Environmental Quality Act (Section 21000 et seq. of the Public Resources Code, hereinafter referred to as CEQA) requires that cities consider the environmental consequences of their actions before approving a project; and

WHEREAS, the Project is a project under CEQA; and

WHEREAS, Section 15301 (Existing Facilities) of the State CEQA Guidelines (Chapter 3 of Division 6 of Title 14 of the California Code of Regulations) provides an exemption from CEQA for projects involving the minor alteration of existing public or private facilities when the alteration involves negligible or no expansion of an existing use; and

WHEREAS, an invitation to bid was duly advertised on April 6, 2016 and April 13, 2016, and bids were opened on May 10, 2016; and

WHEREAS, Martin General Engineering, Inc. was determined to be the responsible bidder submitting the lowest responsive bid.

WHEREAS, R&R Pacific Construction was determined to be the responsible bidder submitting the second lowest responsive bid.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby finds this Project exempt from CEQA pursuant to State CEQA Guidelines Section 15301.

The proposed Project is exempt from CEQA pursuant to section 15301 of Finding: the State CEQA Guidelines.

The proposed Project is exempt from CEQA pursuant to State CEQA Evidence: Guidelines Section 15301 (Existing Facilities). This exemption applies to the minor alteration of existing public or private facilities when the alteration involves negligible or no expansion of an existing use. The proposed project will consist of the following: excavation, grading, concrete work, underground storm drain, asphalt concrete paving to construct approximately 260 feet of curb, gutter, and sidewalk at Strawberry Creek connecting the existing sidewalk on Elk Grove-Florin Road. No trees will be removed and no special circumstances exist that would create a reasonable possibility that the Project will have a significant adverse effect on the environment. Therefore, this project qualifies for the identified exemption and no further environmental review is required.

AND BE IT ALSO RESOLVED that the City Council of the City of Elk Grove hereby:

- 1) Authorizes the City Manager to execute a construction contract with Martin General Engineering, Inc. for the Elk Grove-Florin Road Sidewalk Infill at Strawberry Creek Project (WAC016), in the amount of \$115,997 upon receipt of all required bonds and insurance and the approval of such bonds and insurance by the City Attorney;
- 2) Authorizes the City Engineer to approve change orders not-to-exceed \$20,000; and
- 3) Authorizes the City Manager to execute a construction contract with the second lowest responsive bidder, R&R Pacific Construction, in the amount of \$150,262 upon receipt of all required bonds and insurance and that approval of such bonds and insurance by the City Attorney if, Martin General Engineering, Inc., does not meet filing obligations.
