RESOLUTION NO. 2016-127

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE DISPENSING WITH THE FORMAL BIDDING REQUIREMENTS PER ELK GROVE MUNICIPAL CODE SECTION 3.42.180(B)(3) AND AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT WITH PERFORMANCE AUTOMOTIVE GROUP, INC., A CALIFORNIA CORPORATION DBA ELK GROVE FORD FOR THE PURCHASE OF TEN FISCAL YEAR REPLACEMENT AND ONE ADDITIONAL FORD POLICE INTERCEPTOR UTILITY VEHICLES IN AN AMOUNT NOT-TO-EXCEED \$364,000, WITH AN OPTION TO PURCHASE AN ADDITIONAL THREE VEHICLES FOR A TOTAL COMPENSATION AMOUNT NOT-TO-EXCEED \$463,000

- **WHEREAS**, the City of Elk Grove's Fleet division maintains all City vehicles and procures replacements when necessary; and
- **WHEREAS**, the City's Fleet division has identified ten police vehicles that have reached their useful life of City service and require replacement; and
- WHEREAS, the Elk Grove Police Department has increased their field service staffing levels by two sworn officers this fiscal year therefor requiring an additional patrol vehicle to be added to the fleet: and
- WHEREAS, the City's Fleet division anticipates purchasing up to an additional three vehicles in fiscal year 2016-2017 to replace vehicles in City's existing fleet that may become damaged by collision; and
- **WHEREAS**, the State of California opened a competitive bidding process for the purchase of Ford police patrol utility vehicles; and
- WHEREAS, Performance Automotive Group Inc., a California Corporation dba Elk Grove Ford (Elk Grove Ford) has been asked to match the prices of the State issued contract to purchase the vehicles in Elk Grove; and
- WHEREAS, Elk Grove Ford agreed to match the prices posted in the State of California's large quantity contract award, which was competitively bid, thus the City is receiving a competitive price; the expenditures of staff time and money to compile the necessary bid documents for a small quantity of vehicles will not likely result in a better price or an outcome more advantageous to the City; and Elk Grove Ford is located within the City of Elk Grove and therefore one percent of every taxable sale will return to the City; and
- **WHEREAS**, for the reasons presented, it is not in the best of interest of the City to conduct formal bidding for the purchase of the subject vehicles; and
- **WHEREAS**, Fleet Services and the Police Department has sufficient funding identified in its 2016-17 fiscal year operating budget for this purchase.

NOW, **THEREFORE**, **BE IT RESOLVED** that the City Council of the City of Elk Grove hereby determines that formal competitive bidding is not in the best interest of the City for the subject vehicles and hereby dispenses with the formal bid requirements pursuant to the Elk Grove Municipal Code Section 3.42.180(B)(3) for a contract for the purchase of the subject vehicles; and

BE IT FURTHER RESOLVED that the City Manager is hereby authorized to execute a contract with Performance Automotive Group, Inc., a California corporation doing business as Elk Grove Ford for the purchase of eleven Ford police patrol interceptor utility vehicles in an amount not-to-exceed \$364,000, with an option, in the City Manager's discretion, to purchase an additional three vehicles for a total compensation amount not-to-exceed \$463,000.
