# A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE GRANTING THE ELK GROVE WATER DISTRICT A WATERLINE EASEMENT OVER A CITY-OWNED PARCEL ADJACENT TO PROVENCIAL COURT

WHEREAS, the City of Elk Grove (City) is fee owner of a parcel of land along the northeast corner of Iron Rock Way and Hampton Oak Drive, located north of McConnell Park, is and east of Provencial Court, identified as Assessor's Parcel Number 134-0740-042-0000; and

WHEREAS, Elk Grove Water District (District) is constructing a 16" waterline from its railroad facility to connect to the waterline in Provencial Court as part of the Railroad Corridor South Transmission Main Project 8030.040 (Project), and, in order to make the final connection, the District needs to go through City-owned property; and

**WHEREAS,** City staff has reviewed the District's plans for the waterline and the City is willing to grant the District an easement for waterline purposes, together with the right of ingress and egress; and

WHEREAS, the District has prepared the necessary legal description, attached hereto as Exhibit "A" and shown on the plat attached hereto as Exhibit "B" and the attached easement cover sheet, attached hereto as Exhibit "1".

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby finds:

- a. The Project is exempt from the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines Section 15282(k), which provides that the installation of new pipeline or maintenance, repair, restoration, removal, or demolition of an existing pipeline, as set forth in Section 21080.21 of the Public Resources Code, is exempt from CEQA, as long as the project does not exceed one mile in length.
- b. That the grant of the waterline easement over the City-owned property would be consistent with and not violate the General Plan and all elements and components thereof; and
- c. That the public interest will be served by the herein set aside.

AND BE IT FURTHER RESOLVED that the easement, as described in the legal description labeled Exhibit "A" and as shown on the attached Exhibit "B" and attached to the easement deed cover sheet shown as Exhibit 1, is approved and is ready for recordation; and

BE IT FINALLY RESOLVED that the City Council of the City of Elk Grove authorizes and directs the City Manager to sign the easement deed attached hereto as Exhibit 1 granting the waterline easement as described in Exhibit A thereto and as

shown on the plat labeled Exhibit B, and to send the executed Easement Deed to the District for its acceptance by its governing body and to have it returned to the City Clerk for recordation at the County Recorder of the County of Sacramento..

#### EASEMENT FOR WATER PIPELINE

## The City of Elk Grove A Municipal Corporation

do(es) hereby grant to the Florin Resource Conservation District, a public agency organized and operating under the laws of the State of California, (hereinafter referred to as "FRCD"), for the purpose of installation, construction, reconstruction, maintenance, repair, and operation of water pipelines, and related appurtenances and work auxiliary thereto, a water pipeline easement for the placement, repair, and maintenance of a waterline that would comply to the standards of a waterline placed under and at appropriate depths below the Light Rail and it's corridor operated by the Sacramento Regional Transit District over that certain real property in the City of Elk Grove, County of Sacramento, State of California, bounded and described as follows, to-wit:

# SEE EXHIBITS "A" and "B" attached hereto and made a part hereof;

together with the perpetual right and privilege of flowing potable water in, through, and along said pipeline in such amounts and at such times as FRCD shall deem necessary, and the perpetual right of ingress to and egress from said property, for the purpose of exercising and performing all of the rights and privileges herein granted. This easement will be subject to and take the second position to any future easement granted to the Sacramento Regional Transit District (RT) or any other agency for the purpose of operating a transit system including but not limited to a Light Rail System. Should such waterline conflict with a transit system easement or a light rail easement it may require FRCD to relocate its line at FRCD's expense at the city's sole discretion.

To the fullest extent permitted by law, the FRCD shall indemnify, protect, defend, and hold harmless City, its officers, officials, agents, employees and volunteers from and against any and all claims and lawsuits, damages, demands, liability, costs, losses and expenses, including without limitation, court costs and reasonable attorneys' and expert witness fees, arising out of any failure to comply with applicable law, any injury to or death of any person(s), damage to property, loss of use of property, economic loss or otherwise arising out of the performance of the work described in this easement, to the extent caused by a negligent act or negligent failure to act, errors, omissions, recklessness or willful misconduct incident to the performance of sanitary pipe work performed by the FRCD expect such loss or damage, to the extent, is caused by the sole negligence, or willful misconduct of the City.

The right to indemnity under this Section arises only upon	n occurrence of an eve	ent giving rise to a	claim and or
lawsuits and, thereafter, upon tender in writing to FRCD.			

Nothing in this indemnity obligation shall be construed to create any duty to, any standard of care with reference to, or any liability or obligation, contractual or otherwise, to any third party.

The provisions of this indemnity obligation shall survive the expiration or termination of the Agreement.


