A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE DISPENSING WITH COMPETITIVE BIDDING PURSUANT TO ELK GROVE MUNICIPAL CODE CHAPTER 3.42 AND AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT WITH MOTOROLA SOLUTIONS FOR THE PURCHASE OF TWENTY-SEVEN (27) MOBILE POLICE RADIOS IN AN AMOUNT NOT TO EXCEED \$120,000

WHEREAS, the Sacramento Regional Radio Communications System (SRRCS) is a network of radio communications equipment that supports a regional public safety/public service partnership; and

WHEREAS, the Elk Grove Police Department is a member of SRRCS; and

WHEREAS, since 1994 there have been upgrades and modifications to the system in an effort to maintain an updated system; and

WHEREAS, in 2013, SRRCS began transitioning to a new radio communications system because further upgrades, repairs, and technical support of existing system would soon be unavailable; and

WHEREAS, the Department's current mobile radios have reached their life cycle and will no longer be compatible with the regional radio communications system; and

WHEREAS, it is necessary that all of the Department's mobile police radios be replaced with those that meet SRRCS standards of compatibility; and

WHEREAS, pursuant to Elk Grove Municipal Code Sections 3.42.180(B)(4) and 3.42.220, the City Council may dispense with the competitive bidding process when the purchase is processed through a cooperative purchasing agreement; and

WHEREAS, the City will utilize an existing competitive bid agreement between the County of Sacramento and Motorola Solutions for this purchase; and

WHEREAS, the County of Los Angeles has secured competitive pricing for this particular commodity, which may be used by the City through cooperative purchasing; and

WHEREAS, the Police Department has sufficient funding in its Supplemental Law Enforcement Services Fund (2182200-5406002) for this purchase.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby dispenses with competitive bidding and authorizes the City Manager to execute an agreement with Motorola Solutions for the purchase of twenty-seven (27) mobile police radios in an amount not to exceed \$120,000 through a cooperative purchasing agreement.
