A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AMENDING THE FISCAL YEAR 2016-21 CAPITAL IMPROVEMENT PROGRAM FOR
THE BIG HORN / LAGUNA BUS STOP AND SIDEWALK PROJECT
(PROJECT WAC021) BY REPLACING \$67,500 OF COMMUNITY DEVELOPMENT
BLOCK GRANT FUNDS WITH \$67,500 OF GAS TAX FUNDS

WHEREAS, the Big Horn / Laguna Bus Stop and Sidewalk Project (Project WAC021) includes sidewalk infill, intersection curb ramps and a bus pad; and

WHEREAS, the Fiscal Year 2016-17 Budget for the Project contains Community Development Block Grant (CDBG) Funds (Fund 241) that are received via a grant agreement with the federal Department of Housing and Urban Development (HUD); and

WHEREAS, the bids were opened on June 14, 2016 and the City received only one bid; and

WHEREAS, the City awarded the Contract on July 13, 2016; and

**WHEREAS**, HUD subsequently notified the City that the construction costs were ineligible for CDBG funding due to the failure to obtain at least two bids from contractors willing and able to perform the work; and

WHEREAS, HUD agreed that design and construction management costs remain eligible uses of CDBG funding on the project; and

**WHEREAS**, applying CDBG funding only to preliminary and construction engineering costs resulted in \$67,500 in unfunded construction costs; and

**WHEREAS**, the Fiscal Year 2016-17 Budget contains sufficient fund balance to allocate \$67,500 in Gas Tax funds to the Project.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby amends the 2016-21 Capital Improvement Program for the Big Horn / Laguna Bus Stop and Sidewalk Project (Project WAC021) by replacing \$67,500 of Community Development Block Grant Funds (Fund 241) with \$67,500 of Gas Tax Funds (Fund 221)
