

RESOLUTION NO. 2016-233

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
ACCEPTING THE ELK GROVE-FLORIN ROAD SIDEWALK INFILL PROJECT
(WAC016) AS COMPLETE; AND AUTHORIZING THE CITY ENGINEER TO
PREPARE AND THE CITY CLERK TO FILE THE NOTICE OF COMPLETION WITH
THE SACRAMENTO COUNTY RECORDER**

WHEREAS, on June 8, 2016 the City Council authorized the award of a construction contract to Martin General Engineering, Inc. for the Elk Grove-Florin Road Sidewalk Infill Project (WAC016); and

WHEREAS, the Project constructed approximately 260 feet of concrete curb and gutter, 125 feet of concrete sidewalk, and 135 feet of AC path to connect existing sidewalks at the north and south ends of the project; and


WHEREAS, Martin General Engineering, Inc. has completed the work in accordance with the terms and conditions of the contract documents for the Project; and

WHEREAS, if no liens or claims have been filed within thirty-five (35) days of filing the Notice of Completion, the retained payment funds and any remaining amount due will be released to Martin General Engineering, Inc.; and

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby accepts the Elk Grove-Florin Road Sidewalk Infill Project (WAC016) as complete; and,


BE IT FURTHER RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Engineer to prepare a Notice of Completion and the City Clerk to file the Notice of Completion for the Project with the Sacramento County Recorder.


