**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO EXECUTE A CITY PARTICIPATION
AGREEMENT WITH AEG CYCLING, LLC TO HOST THE STAGE 3 START OF THE
AMGEN BREAKAWAY FROM HEART DISEASE WOMEN'S RACE ON MAY 13, 2017**

WHEREAS, the City of Elk Grove supports the production of events that promote the City as a recreational and cultural center that attracts visitors; and

WHEREAS, the Amgen Tour of California (ATOC) is the largest annual spectator sporting event in California and the largest cycling event in North America; and

WHEREAS, less than 3% of the state's 482 incorporated cities are selected annually to host an element of the ATOC and to be selected offers the city unique opportunities for statewide, national and international exposure that has the potential to effectively raise the City's economic development profile; and

WHEREAS, hosting an ATOC event is consistent with the Council's goal to "Distinguish Elk Grove as a city with an array of opportunities for sports and cultural activities for residents of all ages and backgrounds, with venues that also promote and leverage economic growth" and aligns with the Council's "Join the Movement" health and fitness campaign encouraging residents of all ages to engage in activities that support a healthy lifestyle.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute a City Participation Agreement, in substantially the form presented to the City Council, with AEG Cycling, LLC to host the Stage 3 Start of the Amgen Breakaway from Heart Disease Women's Race on May 13, 2017.




