**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
ACCEPTING THE 2016 CITYWIDE CURB RAMPS PROJECT (WAC011) AS
COMPLETE; AND AUTHORIZING THE CITY ENGINEER TO PREPARE AND THE
CITY CLERK TO FILE THE NOTICE OF COMPLETION WITH THE SACRAMENTO
COUNTY RECORDER**

WHEREAS, on June 22, 2016 the City Council authorized the award of a construction contract to TJR Resources, Inc. for the 2016 Citywide Curb Ramps Project (WAC011); and

WHEREAS, the Project removed accessibility barriers by constructing or reconstructing curb ramps, sidewalks, curb and gutter to meet current ADA accessibility requirements at various location throughout the City; and

WHEREAS, TJR Resources, Inc. has completed the work in accordance with the terms and conditions of the contract documents for the Project; and

WHEREAS, if no liens or claims have been filed within thirty-five (35) days of filing the Notice of Completion, the retained payment funds and any remaining amount due will be released to TJR Resources, Inc.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby accepts the 2016 Citywide Curb Ramps Project (WAC011) as complete; and,

BE IT FURTHER RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Engineer to prepare a Notice of Completion and the City Clerk to file the Notice of Completion for the Project with the Sacramento County Recorder.




