A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
APPROVING A MEMORANDUM OF UNDERSTANDING (MOU) REGARDING THE
GOVERNANCE OF THE REGIONAL CONNECT TRANSIT CARD SYSTEM
ON-GOING OPERATIONS, AND AUTHORIZING THE CITY MANAGER TO EXECUTE
ALL FUTURE CHANGES, REVISIONS, AND AMENDMENTS NECESSARY TO
CONTINUALLY IMPLEMENT THE MOU

WHEREAS, in May 2011, the City of Elk Grove joined other transit operators in the six county Sacramento region and the Sacramento Area Council of Governments (SACOG) by becoming party to a Memorandum of Understanding (MOU) for the design and development of the Connect Card System; and

WHEREAS, the MOU for On-going Operations of the Regional Connect Transit Card System details the roles and responsibilities of transit agencies, the regional customer service center (to be operated by the Sacramento Regional Transit District (RT), and SACOG; with cost sharing amongst the transit operators to achieve economies of scale; and

WHEREAS, the MOU protects the City's interests by limiting the purview of the MOU to fare collection, while preserving fare policy and the pricing authority of the individual transit operators; and

WHEREAS, voting rights and requirements are defined, which require support of both RT and a majority of the region's other transit operators to ratify a decision; and

WHEREAS, the MOU requires all participants to comply with requirements and procedures detailed in the Connect Transit Card Regional Operating Rules; and

WHEREAS, the City's share of the on-going operations of the Regional Connect Transit Card System is anticipated to be approximately \$66,000 for Fiscal Year 2017-2018, at which time the system is expected to be fully implemented.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby approves the MOU Regarding the Governance of the Regional Connect Transit Card System On-going Operations, in substantially the form presented to City Council; and

BE IT FURTHER RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to make any necessary changes, revisions, budget amendments, transfers, and accounting entries pertaining to this MOU, and any future revisions to the City's share of the on-going operations of the Regional Connect Transit Card System.
