

RESOLUTION NO. 2017-141

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO EXECUTE A THREE-YEAR AGREEMENT
WITH ONE, THREE-YEAR RENEWAL OPTION WITH CAPITOL CITY UNIFORMS
AND EQUIPMENT FOR THE PURCHASE OF POLICE UNIFORMS IN AN AMOUNT
NOT TO EXCEED \$395,000**

WHEREAS, the Elk Grove Police Department has more than 137 officers and non-sworn staff required to wear uniforms and ballistic vests to perform their duties; and


WHEREAS, staff publicly announced an invitation for bids (IFB) seeking suppliers of police uniforms and ballistic vests that would offer the City of Elk Grove competitive contract pricing; and

WHEREAS, staff evaluated four (4) bids and determined Capitol Uniforms and Equipment provided the most competitive pricing.

WHEREAS, Capitol City Uniforms and Equipment is located in the city of Elk Grove and is eligible for the City's local vendor preference.


NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute a three-year agreement with one, three-year renewal option with Capitol City Uniforms and Equipment in substantially the form presented for the purchase of police uniforms and ballistic vests in an amount not to exceed \$395,000.


