## RESOLUTION NO. 2017-156

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE DISPENSING WITH THE FORMAL BIDDING REQUIREMENTS PER ELK GROVE MUNICIPAL CODE SECTION 3.42.180(B)(3) AND AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT WITH HOLLISTER HONDA FOR THE PURCHASE OF TWO FISCAL YEAR REPLACEMENT POLICE RATED EMERGENCY RESPONSE EQUIPPED HONDA ST 1300PA MOTORCYCLES IN AN AMOUNT NOT-TO-EXCEED \$73,000

- **WHEREAS**, the City of Elk Grove's Fleet division maintains all City vehicles and procures replacements when necessary; and
- WHEREAS, the City's Fleet division has identified two motorcycles that have reached their useful life of City service and require replacement; and
- WHEREAS, in June of 2016, the City announced a formal Invitation for Bid (IFB) for new unused emergency response equipped police rated Honda ST1300PA motorcycles; and
- **WHEREAS**, Hollister Honda of Hollister, California met all of the requirements of the IFB therefore was found to be the lowest responsive responsible bidder and was awarded contract C-16-332 in July 2016; and
- **WHEREAS**, Staff requested Hollister Honda to match the terms and conditions of contract C-16-322; and
- WHEREAS, Hollister Honda agreed to match the terms and conditions of contract C-16-332, which was competitively bid, thus the City is receiving a competitive price; Hollister Honda was the only bidder in the two previous bid solicitations: and the expenditures of staff time and money to compile the necessary bid documents for a small quantity of vehicles will not likely result in a better price or an outcome more advantageous to the City; and
- **WHEREAS**, for the reasons presented, it is not in the best of interest of the City to conduct formal bidding for the purchase of the subject motorcycles; and
- **WHEREAS**, Fleet Services has sufficient funding identified in its 2017-18 Fiscal Year operating budget for this purchase.
- NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby determines that formal competitive bidding is not in the best interest of the City for the subject vehicles and hereby dispenses with the formal bid requirements pursuant to the Elk Grove Municipal Code Section 3.42.180(B)(3) for a contract for the purchase of the subject vehicles; and

BE IT FURTHER RESOLVED that the City Manager is hereby authorized to execute a contract with Hollister Honda, a California corporation or the purchase of two Honda ST13000PA motorcycles in an amount not-to-exceed \$73,000.
